The Monroe Police Department is currently looking for Cornelius Delvontae Aaron-Woody (DOB: 11/15/1992) who is the suspect in the shooting that occurred at 502 Cass St. Monroe, MI 48161. Mr. Aaron-Woody is a black male, black hair, brown eyes, 5'11" tall and weighs approximately 170lbs. Mr. Aaron-Woody should be considered "Armed and Dangerous" and is currently wanted for Attempted Murder. The firearm from the shooting has not been recovered at this point. Anyone coming into contact with Mr. Aaron-Woody should use extreme caution. A search warrant was executed at his residence. As a result, narcotics and a loaded SKS Assault Rifle were recovered from the residence. Numerous other caliber bullets were also recovered.
