CITY OF MONROE PARTNERS WITH BIRD TO LAUNCH ELECTRIC SCOOTER RIDES

Monroe, Michigan – The City of Monroe is partnering with the shared electric scooter company, Bird Rides, to bring e-scooters to the community. Bird Rides offers dockless scooters to residents and visitors as an additional transportation option within the City to help reduce carbon emissions, as well as traffic congestion on roadways. The program officially **launches Wednesday, June 9th**.

The scooters are accessible via a free mobile app wherein riders pay to use the scooter per minute. Scooters can only be used on roads with a speed limit of 35 mph or less, and in street bike lanes. Scooters have a maximum speed of 15mph. Riders are required to be 18 years-old and above to operate the scooters. They are also encouraged to wear a helmet on every ride and required to obey all standard rules of the road applicable to any motorized vehicle.

When users end their ride, scooters must be parked out of the way of pedestrians, never blocking driveways and walkways. Scooters cannot be abandoned on private property – all rides need to end on public property. As per City ordinance, scooters are not allowed on sidewalks or bike paths, including riverside Worrell Trail, but only in the street bike lanes.

Mark Cochran, Assistant to the City Manager & Economic Development Director: "When we completed the National Citizen Survey in 2018, we were excited to discover that the City of Monroe ranks above the national average among communities whose residents appreciate and engage in active transportation modes, such as biking, walking and scooters. We look forward to collaborating with Bird Rides to bring a new amenity for our residents and visitors desiring alternative modes of transportation to get around our City."

Bird offers the following programs that are available for all who qualify:
